

# **Regulations Governing the Conduct of Exhibitions**

- Hanging fees must be paid in full when work is delivered for hanging.
- An artist who has been granted exhibition space and either withdraws late, or fails to submit work for hanging, will require to pay the fees due on the allocated space.
- No work may be removed or substituted during an exhibition.
- The SSBA Exhibitions Committee reserve the right to refuse space to an applicant whose work they deem unsuitable for reasons of painting or framing quality.

## Advice for Artists Exhibiting at the Enchanted Forrest Exhibition

Members **may submit as many paintings as they wish**, provided they have not been exhibited at previous SSBA exhibitions. However, priority will be given to Forrest category paintings.

### Forrest Category Paintings.

We hope that as many members as possible will submit paintings of plants discovered by George Forrest on his plant hunting expeditions to China and the Himalayas. We will accept paintings of plants for the Forrest category, provided they have either a Forrest parent or originated in the above areas. Only paintings in this category will be judged, and a prize awarded for the picture considered best by the Judging Panel.

### Mounts and Framing

Coloured mounts will not be accepted. It is suggested mounts should be either in shades of white, cream, buff or a sympathetic pale tone which picks up the colours in the painting.

Frames should be as unobtrusive and plain as possible so that they do not distract the eye from the picture. White, cream, and natural or limed wood usually work well with most paintings.. The public rightly expect work for sale to be finished to a high standard, so paintings should be professionally framed with quality materials. Please note, metal frames cannot be fitted with mirror plates

### **Pricing of Pictures**

Remember when considering price that there are a number of issues to be considered – cost of paper and artists materials, length of time taken to paint, cost of mounting and framing, (including details such as parking charges etc.) hanging charges, and cost of travel to and from exhibition venues to deliver and collect work; as well as the gallery percentage which will be deducted from the total price, if the picture is sold. Please also remember that under-valuing your work may make it difficult for other artists to sell theirs.

### Sales of cards and prints

Artists may sell cards and prints provided they have been professionally scanned and printed. Cards must contain the right size of envelope, and be in cellophane covers with a price label, (preferably printed as it looks more professional). Remember that cards and prints will also be subject to a gallery charge, and this should also be taken into account when considering pricing.

Prints should be backed, mounted and wrapped in cellophane, and should contain a label giving details of the title, original picture medium, and be signed by the artist as proof of authenticity. It may also contain the artist's email address or website if wished.

### Insurance for Exhibiting

Artist are advised that they require to have their own insurance against loss or damage when exhibiting, as the SSBA cannot be held responsible.

- Delivery On Wednesday 7<sup>th</sup> September between 10:00 am and 11:00 am. at Callendar Park, Falkirk. If you cannot manage to deliver to Callendar Park at that time then please arrange with another SSBA member to deliver pictures for you
- All paintings must have **mirror plates** on them for hanging.
- Labelling Paintings **MUST** contain a swing label (a luggage label is perfect) taped to the top of the centre back of the picture, with details of the title, medium, paper type, artist and price, as a reference for the Park Gallery staff who will hang this exhibition.
- Separate sheets are attached for recording paintings and cards and prints please complete in full as appropriate. An electronic signature is acceptable.
- The hanging fee is £10 per painting for all paintings.
- Callendar Park will take **25% commission on all paintings, cards and prints** so please price accordingly. To receive money owed on any sales made at the exhibition, artists will require to submit an invoice to Falkirk Community Trust (who run Callendar Park). We will try to obtain a copy of the type of invoice required for artists to use. Note Money owed will not be paid till several months after the exhibition ends.
- You may submit any number of paintings provided they have NOT been exhibited in previous SSBA exhibitions. Only Forrest category paintings will be eligible for a prize (see 'Advice for Artists Exhibiting' for details). Pease put 'YES' in the GF column if you are submitting a painting in this category
- The absolute cut-off date for submitting application forms will be midday on 20<sup>th</sup> August 2016

   NO paintings will be accepted after that date and time. Please try to send them well before that date so that if there are any issues with the content of the form it can be resolved in time

- Collection of paintings, cards and prints after 18<sup>th</sup> October. Details will be provided later.
